#### M4775 PUBLIC PARTICIPATION

Members of the public were in attendance to express concern following the announcement of Candidate Sites in Monmouthshire for the next Local Development Plan. They feared that huge development, potentially in Five Lanes, Highmoor Hill, Carrow Hill and other sites in Caerwent could wipe out large areas of forestry, have a massive impact of the environment and impact on their quiet enjoyment of their land and properties. Some of the proposed sites even included land belonging to them. There is a lot of strength of opinion even at this early stage and they queried when the public consultation will take place so that they can voice their opinions and concerns.

Councillor Murphy informed the meeting that this was the first call for Candidate Sites which is standard procedure when a Local Development Plan is being prepared. There will be another call for site proposals within the next two/three months. Once they have all been received they will be considered by Planners who will go through them to consider if they meet the criteria. Many will fail following scrutiny, e.g. development on flood plains, new builds in the countryside, Sites of Scientific Special Interest etc. During the last LDP exercise five sites from our area were taken out. Following this, public consultation will take place, probably in two/three years time.

Monmouthshire have a shortage of statutory land supply - they are 500 houses short - basically because builders have not been building. There is currently pressure from the Welsh Government as lately they have been overturning decisions that MCC have taken.

Councillor Murphy assured the residents that they will be informed of future developments in the newsletter, on social media and through their local Councillors.

A resident queried why a newt survey was carried out recently at Ifton Quarry. Councillor Murphy advised that all sorts of ecological surveys are carried out (newt, bats, slowworms, flora/fauna) when a development is proposed but he was unaware of this actual survey.

## To consider recent instances of dogs off leads and whether Cadw signage is adequate.

A number of complaints had been received regarding dogs off leads around the roman wall including verbal confrontation towards visitors to the site who had raised this issue. Council agreed that they were appalled by such behaviour and agreed to mention this in the next newsletter. Agreed to contact Cadw to query if they believe that their signage is adequate and also possible enforcement action of the site. Councillor Counsell proposed that the fences be taken down so that the dog problem is not concentrated on the wall. The Chair was concerned that the fields would then not be grazed and would lead to different problems. Councillor Murphy will in the meantime check with MCC who actually rent the fields.

## M4789 HIGHWAYS/RIGHTS OF WAY

## Crick Highways Signage

To consider purchase of 3 new village signs for Crick (One replacement for the very small sign already located on the A48 east entrance to the village. Two new signs – one located on Crick Road entrance to village and the second located on entrance to village from Shirenewton)

Councillor Swift had been in contact with Highways. She was advised to contact Standard Signs in Newport to obtain firm quotes with installation for future consideration.

#### To report any highways/rights of way issues

Potholes:

In centre of carriageway A48 east, just before the Crick sign.

Five Lanes nr Five Lanes House, nr telephone box.

Highmoor Hill - all along the lane.

Cycle path on A48 - weed killing not thorough, needs spraying every year for several years.

Fallen oak tree on land off Highmoor Hill – between Hardwick Farm and Woodcock Cottage travelling west.

Councillor Lewis reported that he is meeting with the Footpaths Department very soon.

Back of bus shelter in Crick (east) – overgrown with brambles. To report to handyman.

Merton Green lights now all numbered and adopted.

Confirmation received that St Tathan's and the Old Shirenewton Road are publically maintained highways. Their condition has been repeated again to the maintenance team. Report received that potholes will be filled and resurfacing considered for the future.

MCC had confirmed that they had recently submitted a bid to Welsh Government to undertake a route feasibility study on the A48 from Highbeech Roundabout to the county boundary with Newport City Council. The reason for this is to further analyse the collision data recorded and develop appropriate schemes to address the causations of the casualties, with a view to implementing a road safety grant scheme in 2020-21 financial year, subject to additional funding being received from Welsh Government. Councillor Swift requested that we seek again to obtain the assessment check regarding speed reduction from the Pwyllmeyric survey so that we can understand if the situation differs from Crick.

## M4789 REPORTS OF REPRESENTATIVES ON OUTSIDE BODIES

Councillor Murphy advised that he had resigned as a Local Authority representative on the Shirenewton Governing Body due to regular diary clashes although he has informed them that he is very happy to aid them if required.

Councillor Swift reported that CWEP have offered to help the MCC Officers, Alison Howard and Mark Cleaver who are involved in the new 'Nature isn't Neat' pilot project to raise awareness for the need of pollinators through its community wildflower meadow and nature reserve in Crick, by communicating with local residents and also with the other groups that have links with them.
