UPDATES ON TRAFFIC CONCERNS RAISED BY RESIDENTS AND COMMUINTY COUNCIL

There was a site meeting with MP David Davies and Councillors Murphy and Dalton in December.

Police Enforcement of 20mph is to take place in the near future 20mph signs to be resited.

New Yellow Road Markings have been painted on the road on sides of bus stops Volume of traffic and parked cars remain a concern although the parked cars are helping to slow traffic down

The lack of visibility is mainly due to bend in field and hedge growth, but if the hedge is cut this may encourage drivers to go faster.

Councillors concerned at the actual position of the Bus Stop for Chepstow..could it be reinstated in a safer place due to the number of pupils now using it? Councillor Murphy to consult Richard Cook MCC regarding hedge and bus stop. Clerk to consult Graham Kinsella about signage in that area.

M4034 DISCUSS FURTHER PROGRESS ON THE UPKEEP OF CAERWENT PLAYING FIELDS TRAIL

CPFA have agreed to hold a weed pulling event alongside an Easter Egg Hunt in April.

CPFA wondered whether suitable shrubs could be planted on barked area of the trail. Caerwent Meadows and Crick Wildlife Group to be contacted for advice. Councillor Swift and Guscott to meet at the trail before next meeting to look at possibilities.

There has been some improvement to the unkempt border on the edge of the trail on St Tathan's side.

Clerk has also received a message from another resident who is in the process of clearing a lot of overgrowth on their fence bordering the trail.

Councillor Murphy said there was no further progress, but this will stay on the agenda

M4036 CONSIDER HOW WE MAY ENGAGE IN A FULLY FUNDED EV CHARGING POINT SCHEME

Councillor Murphy has taken advice on the matter and although there was some work being done with CCR and Kerb Connected, Caerwent village would not be a viable candidate at present due to not having a suitable Car Park.

Councillor Swift informed council that reporting on this is a statutory requirement. A new working group needs to be convened to discuss how we might implement this. Clerk to circulate an email regarding setting up a new working group.

Councillors encouraged to challenge residents if they are seen to be not picking up dog excrement.
