## To consider groundwork safety at the site

Councillor Phelps agreed to visit the site and take photographs. To be discussed at the next meeting. It was noted that it is a community asset and could possibly be moved to a different location.

## M4884 WELSH GOVERNMENT AWARD - BUS STOP INFRASTRUCTURE

To note that MCC has received £290,000 towards this.

To consider enquiring if our older bus shelters could be included in the review.

The Clerk advised that plans are already agreed within the bid for improvements in other areas but there could be a possibility that funds are left following completion of these. Council agreed to contact MCC regarding being included in the later review.

## M4885 EMBRACE NATURE CAERWENT PROJECT

## To approve licence document provided by Cadw

Council agreed to approve the licence provided that Stephen Smith of Embrace Nature Caerwent is in agreement with the clauses. Clerk to contact him. The Clerk advised that this licence is for a period of five years with the licensee able to terminate giving three months notice, providing that the sub-licence has also been terminated.

Councillor Phelps will be attending a meeting of Embrace Nature Caerwent next week and he was asked to mention Clause 6 in particular regarding re-seeding.

## To consider ownership of tools/equipment

Council agreed to take ownership as per Cadw request subject to the availability of storage on site and for the equipment to be maintained by ENC.

Councillor Phelps agreed to seek information from ENC regarding storage of equipment and insurance cover with particular reference to equipment and volunteer working.

The Clerk advised that annual monitoring of the project would be built in as a condition of the grant. Councillor Harris proposed that our Environment Working Group could be involved in the overseeing of the project.

Clerk will draw up a sub-licence as per the Cadw licence and send to ENC.

Foodbank request - already carried out in Caerwent at Post Office

Signage on footpath at Manor Farm to deter dogs from entering – Councillor Harris had visited the site, reported that it appeared that the community on the whole supported the signage and that the signage appeared to be working, in that farm animals are being protected as no dogs are now entering the fields. Since the lockdown pandemic there had been considerably more walkers and the signage had therefore been placed. They will probably be removed after lockdown. Councillor Haddow agreed to also visit the site.

## M4889 HIGHWAYS/RIGHTS OF WAY

## To report any issues

Barbed wire on fence at Manor Farm alongside Shirefield Cottage to Highmoor Hill. Clerk had contacted the Countryside Access Manager and was provided with the following information:

16.3 Barbed Wire Alongside A Public Right Of Way

Where a barbed wire fence is situated alongside a Public Right of Way it may be a danger and a nuisance to members of the public. If in the opinion of the County Council the barbed wire does represent a danger to the public then the County Council has a protocol of firstly asking the owner to make the fence safe for members of the public using the path. If the owner refuses or fails to do so the County Council will serve legal notice requiring the owner to remove the source of danger within a specified time. (Highways Act 1980 section 164.)

Agreed to contact MCC to seek clarification on this actual wire and also to request some waymarkers. Council noted that neighbouring farms/footpaths also had barbed wire installed. Councillor Haddow also agreed to walk the footpath and report back.

Footpath from Burton Villas to the triangle field very overgrown with briars at child eye level.

20 mph signage near the toilets still not working despite being reported twice. Councillor Swift will contact MCC regarding the proposed speed reduction in Crick. Clerk was asked to contact MCC regarding delayed highways works.
